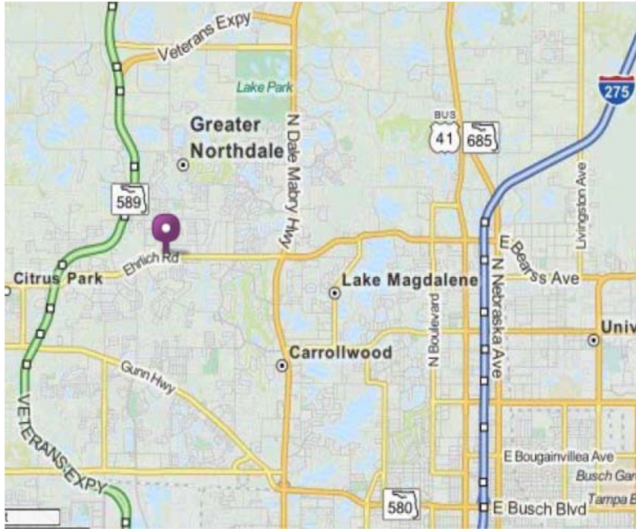

## Training Location – Shulman ADR Law, P.A. 5111 Ehrlich Road, Suite 120, Tampa, FL 33624



**From I-275:** Take I-275 to Bearss Avenue exit and head west approximately 4.8 miles (note that, at North Dale Mabry Highway, Bearss Avenue becomes Ehrlich Road). After the traffic light at Pennington Road, the entrance to Pennington Professional Park is on right. Suite 120 is immediately in front of you, near the handicap parking. **From Veterans Expressway:** Take Ehrlich Road exit and head east on Ehrlich Road approximately 1.8 miles to traffic light at Pennington Road. Make U-turn and enter parking lot for Pennington Professional Park immediately on right. Suite 120 is immediately in front of you, near the handicap parking. **From Dale Mabry Highway:** Take Dale Mabry to Ehrlich

Road/Bearss Avenue intersection, and go west 1.8 miles. After the traffic light at Pennington Road, the entrance to Pennington Professional Park is on right. Suite 120 is immediately in front of you, near the handicap parking. **From Tampa International Airport or from SR 60 from Clearwater:** Take the Veterans Expressway (SR 589) north to the Ehrlich Road exit. Follow directions above from Veterans Expressway. **From I-4:** Take I-4 west to I-275 north to the Bearss Avenue exit; follow directions from I-275 above. **From I-75 (South or North of Tampa):** Take I-75 to I-275; follow the directions from I-275 above.
